# POLICE DEPARTMENT MILLAGE PROPOSAL FOR POLICE MAINTENANCE AND OPERATION ORONOKO

**Proposal Text**

Shall The Charter Township of Oronoko be authorized to levy a tax annually upon the taxable value of all property subject to ad valorem taxation in an amount not to exceed 4.0 mills (\$4.00 for each \$1,000 of taxable value) for each of the three (3) years, 2018, 2019 and 2020 within The Oronoko Charter Township for the purpose of defraying the cost of providing police services, including, but not limited to, the maintenance and operation of the Berrien Springs Oronoko Township Police Department, the purchase and housing of police apparatus and equipment. This millage is a renewal of the previously authorized millage of 3.96680 mills which expired in 2017, and a new additional millage of .03320 mill to restore millage lost as a result of the Headlee Amendment reduction, for a total authorized millage not to exceed 4.0 mill. This millage, if levied, is estimated to provide revenues for the Berrien Springs Oronoko Township Police Department of \$962,360 in its first year of 2018.
