To the qualified electors of all Cities and Townships in the County of Berrien, State of Michigan.

NOTICE IS HEREBY GIVEN THAT said City and Township Clerks will be at their offices indicated hereafter on Monday, October 4, 2004-----LAST DAY-----from 8 o'clock A. M. until 5 o'clock P. M., the 30th day preceding said General Election as provided by Section 498, Act No. 116, Public Acts of 1954, as amended for the purposes of reviewing the registration and registering such of the qualified electors in said CITY or TOWNSHIP as SHALL PROPERLY apply therefor.

The name of no person, but an ACTUAL RESIDENT of the precinct at the time of registration and entitled under the Constitution, if remaining such resident, to vote at the next election, shall be entered in the registration book.

Republican Party, Democratic Party, Green Party, U.S. Taxpayers Party, Libertarian Party and Natural Law Party candidates and candidates without political party affiliation seeking election to the following partisan offices are to be voted for in this county: President and Vice President, Representative in Congress, State Representative, State Board of Education, University of Michigan Regent, Michigan State University Trustee, Wayne State University Governor, county offices, township offices and such other partisan offices that may by law be required to be elected at this election. Candidates seeking election to the following nonpartisan offices are also to be voted for in this county at the November 2, 2004 General Election: Supreme Court Justice, Appeals Court Judge, Circuit Court Judge and District Court Judge and such other nonpartisan offices that may by law be required to be elected at this election.

Any voters requesting voting instructions in an "alternative format" i.e. cassette tape in advance of the election shall be supplied with a copy of the tape.
