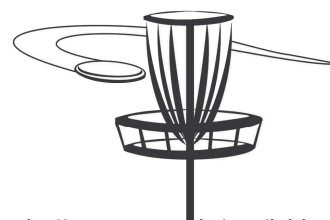

\$20.00 for those 15 or younger
Limited to 76 players and no refunds

LATE-REGISTRATION: Add \$5.00 to Pre-Registration prices. (If openings are available).

DIVISIONS: Please note, it is the players' responsibility to compete in the appropriate division. The tournament director will automatically bump a player into a higher division if his/her first round score is lower than the 'at best' score. (Course par: 70)

1. Open - Designed for golfers that throw better than 13 under course par at best.
2. Amateur I - Designed for golfers that throw 13 under course par at best.
3. Amateur II - Designed for golfers that throw 8 under course par at best.
4. Amateur III - Designed for golfers that throw 2 under course par at best.
5. Master's Amateur - Designed for amateur golfers age 40 and over.
6. Sr. Master's Amateur - Designed for anyone age 55 or over.



AWARDS: All participants will be competing for trophies, which will be awarded to the first three places in each division. There will also be awards for the following contests: "**Hole in One**" and "**Closest to the Pin**".
